#### 'Transhumanism is Satanic'

To a moderate extent I believe that transhumanism is satanic. As although I do believe technology such as mobile phones, scanner pens, cosmetic procedures, pacemakers and prosthetic legs for example can be complimentary to the physical human form. I also believe transhumanism is a spectrum and on its extreme side, technology that completely neglects and abandons our humanity can be considered satanic as we are all made in God's Image with humanity, lives. This may cause tensions in employment, sporting that must be preserved.

The main problem arises when technology and science is used as some archetype of salvation in the absence of God. The need to become "posthuman" by avoiding the sufferings that come with being human through Godless means is satanic. God does give us gifts and talents such as science to endure woes of humanity such as medicine and we can continue to explore the possibilities on this but when we seek be in complete independent control of how own mortality, we ultimately attempt to damage the plan of God and that's where the issue lies. Moreover, Jesus became our salvation and that is the core of Christianity and so if we reach this posthuman state the core element of Christianity ceases to be. Another example of God's plan being negated is the idea we can achieve wisdom through enhanced cognitive capacity, again absent from God, but our knowledge and wisdom are sourced from God. Therefore, one consequence of all this is the divides on who can access this "posthuman" state and who can't, as all are humans are welcome to God's promise, but this might not be the case in accessibility within transhumanism. We already see this in who has access to basic needs like food and water but also who's most impacted by climate change, access to medicine, education, electronics, cosmetic products/procedures (e.g., anti-aging agents) and furthermore the divides of accessibility of those resources between countries, regions and classes. And with the addition of things like immortality, "super-human" abilities well-being and living conditions. However, the satanic etc the idea that one could have all and some with none could lead to quite dystopian future. This being not on God, mixed with human greed and vulnerability to corruption, may mean that divisions of opportunity, resources and security are mortality, fragility and weaknesses is just as important as quite plausible.

However, transhumanism does offer potential benefits such as being a catalyst to agricultural and medicinal breakthroughs. Innovations in healthcare technology may mean the increase of survival rates of extreme conditions like heart disease and cancer and even detecting early signs of these illnesses arising. And so, if utilised correctly transhumanism

can target the most vulnerable and deprived groups who can seek resources and knowledge to better their living conditions such as produce of food and access to medicine. In this I believe 1 Corinthians 10:23 "I have the right to do anything," you say-but not everything is beneficial" best fits the principle that should be upheld when navigating trans humanism because although new discoveries and findings should be celebrated, limitations and regulations should be established to ensure these findings better people's lives rather than threaten them. If transhumanism seeks to enrich people's lives rather than just add surface level enhancements than one can view this as a gift from God rather than satanic practice.

Nevertheless, a more pessimistic approach of human nature would suggest that even with laws and regulations on the ethics and the practice of transhumanism, the sheer level of power this type of technology would bring may lead to an expediential increase in conflict and devastating consequences. Such as tyranny of the "posthumans" whereby those who opt out of enhancements for various reasons such as religious, personal, legal and health reasons are left inferior and thus obstructed from opportunities in their events and income rates cultivating a culture of "have" and "have-nots" and thus potentially and ultimately leading to an extinction of those "have-nots" for simply opting out of these additional enhancements. We see this already in the argument about whether it is right to use certain drugs in sporting as it disregards the efforts of those who have trained and compete without those enhancements or the use by students of ChatGPT to write up their essays and coursework. If law is made that people can opt out posthuman enhancements much like certain vaccines, then the idea of a meritocratic society ever being achieved is completely disregarded. Contrastingly, if made a compulsory for all to go through this posthuman transformation in order to level this playing field, being man-made posthuman population may lack the diversity and uniqueness that comes with God's creations. We may have the same "super" human abilities such as speed, strength and intelligence but lack that uniqueness that comes with each and every one of our weaknesses and strengths that come with simply being human. And even if given options on what human variations we may desire, there will be abilities more favourable than others supporting the idea we risk becoming clonelike and lacking individuality.

In conclusion, I do not wish to demonise scientific and technological advances as a whole because there are benefits to be celebrated as, if utilised right, can enhance our element arises when we believe there is a need to completely neglect our humanity in the fear of the darker sides of being human. Facing and accepting things like our inevitable aiding and enhancing our quality of life.

#### **RE Curriculum**



**This term RE sees the launch of a new curriculum .** Below is the official and accurate press release for the Curriculum. We commence at St Marys with this exciting new curriculum in a few weeks' time – launching with Year 7.

EDUCATION We are looking forward to the changes to our already robust and vibrant curriculum.

#### *New Religious Education (RE) Directory for Catholic schools, colleges and academies in England and Wales has been launched at an event in Westminster.*

The directory was introduced at Cathedral View on 25 January by speakers including Dr Margaret Carswell, Senior Lecturer at the Australian Catholic University; Baroness Barran MBE, Parliamentary Under Secretary of State at the Department for Education; the Rt Rev Marcus Stock, Bishop of Leeds and Chairman of the Catholic Education Service (CES); and Paul Barber, CES Director.

Titled To Know You More Clearly the directory sets out the purpose of RE from Early Years Foundation Stage to Year 9 and features a programme of study with a model curriculum, corresponding to the six half-terms of the school year.

The new directory replaces previous editions published in 1996 and 2012, and states that RE is to be taught for at least 10% of curriculum time up to age 16 in Catholic schools and academies, and 5% in sixth forms.

It was drafted by experts including the late Professor Anthony Towey, Head of Theology, Philosophy and History at St Mary's University; CES Religious Education Adviser Philip Robinson; Senior Policy and Education Adviser Dr Nancy Walbank; and representatives of the Association of Teachers of Catholic Religious Education and the National Board of Religious Inspectors and Advisers.

Based on the constitutions of the Second Vatican Council and rooted in the Catechism of the Catholic Church, the objective of the curriculum is religiously literate and engaged young people, with the knowledge, understanding and skills to reflect spiritually, think ethically and theologically, and recognise the demands of religious commitment in everyday life.

In his preface, **Bishop Marcus writes:** "As well as seeking to assist parents with the education and religious formation of their children, Catholic schools strive also to be of service to society. Religious education plays its part in this endeavour by enabling all pupils to be confident and secure in their religious faith and knowledgeable and respectful of other religions, and so play a crucial role in building a cohesive society.

"This new edition of the Religious Education Directory strives to embody these inspiring objectives."

Baroness Barran thanked those present and highlighted "the important role Catholic schools, and schools with a religious character more generally, play in giving children a moral compass, guiding them with values that will be integral not only through their school journey, but beyond that into adulthood, into the workforce and into society."

Other attendees at the launch included Schools Commissioners from the Catholic dioceses; and representatives from the Church of England Education Office; Board of Deputies of British Jews; Religious Education Council; National Association of Standing Advisory Councils of Religious Education; Culham St Gabriels; Catholic Union; and from the London Jesuit Centre.

While nurturing the faith of Catholic pupils, the curriculum prepares all pupils to play their part as critical citizens in a plural and diverse culture. It develops in them a dialogical attitude, through the content that is presented and through the modelling of respectful dialogue in class, a particularly powerful witness in a context where social media has had such a detrimental impact on the civility of public discourse.

Topics covered include the relationship between faith and science; the problem of evil; nature of human freedom; rights of the unborn; plight of refugees and asylum seekers; war and peace. There is also a focus on the beauty of Catholicism and its influence on culture through art, music, literature, science, and architecture, equipping young people to engage with the Church beyond intellectual remits, and approach the transcendent.

A series of training workshops on the directory and model curriculum for dioceses are also being planned to take place throughout the year. <u>Download the new Religious Education Directory</u>
